4.1 Description of first aid measures

Eye	Exposure is considered unlikely unless dust is generated. Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes.
Inhalation	If inhaled (dust during machining), remove from contaminated area. Apply artificial respiration if not breathing.
Skin	No adverse effects are anticipated. However, if an adverse reaction due to skin contact occurs, gently flush affected areas with water and discontinue use.
Ingestion	For advice, contact a Poisons Information Centre on 13 11 26 (Australia Wide) or a doctor (at once). Due to product form and application, ingestion is considered unlikely.
First aid facilities	Eye wash facilities should be available.

4.2 Most important symptoms and effects, both acute and delayed
